2 | (NEW ONLINE RESOURCE USERS) CREATE A USER ACCOUNT (CURRENT USERS SHOULD SIGN IN USING THEIR EXISTING ACCOUNT DETAILS AND PROCEED TO STEP 3)

Under **SIGN UP** enter your email address, create and verify a password, enter your first and last name, then enter the word under Word verification. Note: If word verification is difficult to read, click the image until it is easier to read.

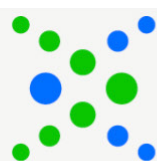
3 | CLAIM A SUBSCRIPTION

After sign up or existing user login, locate and click the **CLAIM SUBSCRIPTION** link in the dark box on the home page to be redirected to enter the premium subscription code required to access the content.

Enter your **PREMIUM SUBSCRIPTION CODE** (just as it appears including hyphens), along with the required site registration information and click Redeem.

Users will have to log back into their account to access the newly redeemed content.
