This session will provide a basic overview of the account-to-account payment systems in Canada, the EU, Mexico, and the UK with an emphasis on the systems used for the domestic leg of (inbound) cross-border payments in these markets. It will conclude with a brief comparison of payment habits in these markets using the US as a benchmark.

9:00 am – 10:00 am **Liability Under PSD3: Regulatory Shifts and U.S. Legal Parallels**

This session will provide a detailed analysis of how PSD3 reshapes liability allocation among banks, payment service providers (PSPs), and consumers in the EU — especially in the context of strong customer authentication (SCA), access-to-account (XS2A), and unauthorized payment transactions. We'll explore how these shifts compare to the U.S. legal landscape, including relevant provisions under the Electronic Fund Transfer Act (EFTA), Regulation E, and the evolving treatment of liability in real-time payments and open banking. The discussion will focus on key divergences and convergences in legal theory and enforcement, and what multinational financial institutions and fintechs need to know to stay compliant and mitigate risk.
